



**GUARANTEE AGREEMENT BETWEEN
THE GOVERNMENT OF MALAYSIA AND
THE GOVERNMENT OF THE
REPUBLIC OF SINGAPORE**

THIS AGREEMENT is made the 24th day of November 1990 between the Government of Malaysia (hereinafter referred to as the Government of Malaysia) and the Government of the Republic of Singapore (hereinafter referred to as the Government of Singapore).

WHEREAS the Public Utilities Board of Singapore (hereinafter referred to as PUB) and the Government of the State of Johor (hereinafter referred to as the Johor Government) have on the 24th day of November 1990 entered into an Agreement for the purchase of treated water by PUB from the Johor Government:

AND WHEREAS the parties hereto are desirous of giving mutual guarantees for the due performance and observance of all the terms, provisions, conditions and stipulations of the said Agreement to be performed and observed by PUB and the Johor Government respectively:

NOW IT IS HEREBY AGREED as follows:

1 (a) The Government of Singapore hereby guarantees the due performance and observance of all the terms, provisions, conditions and stipulations of the said Agreement on PUB's part to be performed and observed according to the true purport, intent and meaning thereof.

(b) If and whenever PUB shall fail to perform or observe any of the terms, provisions, conditions and stipulations of the said Agreement, the Government of Singapore shall perform and observe the same on behalf of the PUB or do everything which is necessary to ensure that PUB shall perform and observe the terms, provisions, conditions and stipulations of the said Agreement.

2 (a) The Government of Malaysia hereby guarantees the due performance and observance of all the terms, provisions, conditions and stipulations of the said Agreement on the Johor Government's part to be performed and observed according to the true purport, intent and meaning thereof.

(b) If and whenever the Johor Government shall fail to perform or observe any of the terms, provisions, conditions and stipulations of the said Agreement, the Government of Malaysia shall perform and observe the same on behalf of the Johor Government or do everything which is necessary to ensure that the Johor Government shall perform and observe the terms, provisions, conditions and stipulations of the said Agreement.


3 The guarantees contained in this Agreement shall continue for the whole of the duration of the 1962 Johore River Water Agreement unless the Johor Government and the PUB, on such terms and conditions as may be agreed, extend the Johore River Water Agreement beyond the date of the expiry of the said Agreement, in which event the said guarantees shall continue to be applicable for the period extended by the new agreement.
